Revisions to Section F of EAVS

As part of its efforts to make the EAVS easier to complete and to improve data quality and completeness, the EAC has revised portions of Section F in the 2018 EAVS. Based on feedback from election officials, the EAC knows that Section F questions on voting technology have been among the most difficult questions to answer in years past. Revisions for 2018 have been designed to help respondents provide a clearer picture of the types, makes, and models of voting technologies and how these technologies were used in the 2018 elections.

Given the heightened focus on election security and election technologies following the 2016 elections and ongoing concerns surrounding aging voting equipment, data quality improvements in this area are expected to give election jurisdictions, Congress, and other election stakeholders more comprehensive and reliable information on what voting technology is in use across the country. The voting technology questions have been revised in the following ways:

- Respondents will first classify their technology by equipment type (DRE w/o VVPAT, DRE w/ VVPAT, ballot marking device, scanner, punch card, lever, hand count), as opposed to by use of equipment.
- Respondents will now have the option to report up to three makes and models for each equipment type (e.g. for jurisdictions that use different scanners for precinct- vs. central-count locations).
- Based on information provided by the EAC's Testing and Certification program, there will be a drop-down list in the Online Template and the Excel Data Aggregation Template with the most common makes and models to help you more accurately report what equipment you are using. Pre-filled options will be organized alphabetically by the model name, with the make of the equipment listed in parentheses, e.g., "eSlate (Hart)" or "M650 (ES&S)".
 - If your jurisdiction's equipment is not listed in the pre-filled options, you may use a text box to enter in your make/model information.
- The location of the vote tallies has been moved to a separate question grid and should be reported according to the use of the equipment (in-precinct Election Day regular ballot voting, special device accessible to disabled voters, provisional ballot voting, in-person early voting, or by-mail voting).

The voting technology questions have been renumbered to F5-F11:
