# Wrapping Up the 2024 EAVS and What To Expect In the Future

Thank you for another successful iteration of the Election Administration and Voting Survey (EAVS)! The U.S. Election Assistance Commission (EAC) and the EAVS project team appreciate the work so many state, local, and territory election officials have put in to provide EAVS data for the 2024 general election. The data you provide plays an important role in promoting information sharing, feedback, and continuous improvement, all of which help strengthen the election administration process across the United States.

If you have not yet submitted the final data for your state or territory, please do so as soon as possible, as the <u>2024 EAVS data will be locked on Monday</u>, <u>March 31, 2025</u>. Any data updates or changes received after that date will not be included in the 2024 EAVS comprehensive report to Congress or in the initial public data release. Alternatively, if your state or territory has certified its EAVS and Policy Survey data submission as final, please remember to complete the customer satisfaction survey that you received by email. Although this survey is not required, any feedback you share will help the EAVS project team assess what worked well for the 2024 EAVS, what didn't work, and what can be improved in the future.

## Coming This June: The EAVS Comprehensive Report and Data

Once the 2024 EAVS data are locked, the EAVS project team will begin analyzing the data and writing the 2024 EAVS comprehensive report to Congress, which will highlight election administration and voting trends for the November 5, 2024, general election. We anticipate that the report will cover the following topics:

- An overview of election administration and election activities, including the total number of votes cast, turnout rates (in total and by mode), registration rates, the number of precincts and poll workers, drop box use, provisional balloting, and use of election technology
- A report on the Policy Survey, including policies on voter registration and list maintenance; mail voting; in-person voting before Election Day; Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) voting; provisional voting; election technology, election certification, recounts, and audits; voter identification; and how a criminal conviction affects voter registration
- A report on the National Voter Registration Act (NVRA) voter registration activities during the previous two-year election cycle, including the total number of registered voters, the modes by which registration transactions were processed, the types of registration transactions



processed, use of same-day voter registration, removal or confirmation notices sent to voters, and records removed from registration lists

- A report on data related to UOCAVA voting, including the total number of registered and eligible UOCAVA voters; the number of Federal Post Card Applications (FPCA) received, accepted, and rejected; the total number of UOCAVA absentee ballots transmitted, returned, cast, and counted; the number of UOCAVA absentee ballots not counted and the reason for rejection; and the number of Federal Write-In Absentee Ballots (FWABs) returned and cast by UOCAVA voters
- A report on the methodology of the Policy Survey and the EAVS, including an overview of the
  project timeline, how data were collected and analyzed, and technical assistance and other
  support provided to states and territories

The EAC will deliver this comprehensive report to the U.S. Congress and publish the report, the 2024 EAVS and Policy Survey data sets, and the data codebooks on its website no later than June 30, 2025. To be notified of the exact release date, follow the EAC's social media channels on X, Facebook, LinkedIn, YouTube, and Instagram. The report and data will be posted on the Surveys and Data page of the EAC website when they are available.

Once the 2024 EAVS report and data have been published, the EAC plans to release additional visualizations and reports using the EAVS and Policy Survey data later this year. These additional research products will be announced through the EAC's social media channels as well.

## What's Next For the EAVS? 2024 After-Action and Preparations For 2026

Although the 2024 EAVS will be winding down over the next few months, work on this project is still ongoing. In late summer and early fall 2025, the EAVS project team will undertake a systematic assessment of the 2024 EAVS to identify ways to continue improving the EAVS as a resource to support U.S. election administration and election officials.

#### Post-2024 Needs Assessment

The first part of this after-action effort will be to engage in needs assessment conversations with state and territory EAVS points of contact (POC). The project team will invite POCs to participate in a phone or video call to discuss their state or territory's EAVS experience in 2024, as well as feedback shared in the post-certification customer satisfaction survey (if the POC completed the survey). POCs can expect these invitations to be sent by email in September or October 2025. POCs are also invited to submit written feedback to the EAVS project team at any time at <a href="mailto:eavs@forsmarsh.com">eavs@forsmarsh.com</a>. We appreciate all feedback and advice on how we can make the EAVS easier for election officials to complete, either at the state/territory level or the jurisdiction level.



#### Files On the EAVS Portal

To prevent unauthorized access to the information and EAVS data on the EAVS Portal, the EAVS project team plans to disable access to the <u>State Files page</u> on Friday, April 18, 2025. Before the access restriction takes place, we will notify POCs by email and encourage them to download any files they want to retain to their local computer. The files on the Downloads and Resources pages of the EAVS Portal will remain available.

### 2026 EAVS and Policy Survey Questionnaires

The EAVS project team will also begin working on the survey questionnaires for the 2026 EAVS and the Policy Survey soon. We may eliminate survey questions that are no longer relevant, revise questions to better reflect current election practices, or add new questions. The EAC is statutorily required to submit the EAVS and Policy Survey questions to the U.S. Office of Management and Budget (OMB) for review before the survey questions are finalized, a process that takes approximately six months. Links to the draft survey questions will be published to the Federal Register for public comment twice, first for 60 days and then for 30 days. To be notified when the public comment periods are active, subscribe to updates through the Federal Register. The EAVS project team anticipates that the 2026 survey questions will be finalized in spring 2026 and they will be posted on the EAC's website when they are available.

### **Working Groups To Assess EAVS Sections**

Over the next several months, the EAC will also be studying the Section A changes that were implemented for the 2024 survey and will convene working groups to assess Sections B-F and how the EAVS can evolve to become a more useful resource for election officials. The EAC will seek the input of state, territory, and local election officials who complete the EAVS on these topics. You may receive an invitation to provide input or join a working group that will meet virtually, and the EAC hopes you will participate to help ensure EAVS questions remain up to date and the survey's response burden is minimized.
